



Terms & Conditions

Icon FX Welcome 30% Deposit Bonus

These Terms & Conditions (“Terms”) govern the **30% Deposit Bonus** (“Bonus”) provided by Icon FX (“Broker”). By participating in this promotion, you confirm that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, you must refrain from participating in this promotion.

1. Eligibility

- The **30% Deposit Bonus** is exclusively available to **new clients** of Icon FX who have opened a **live trading account** and made their **first deposit**.
- This promotion is **not available** to existing clients or clients who have previously opened an account with Icon FX.
- This offer is valid only for **individual accounts**. Corporate or institutional accounts are excluded.
- The Bonus is offered on a **one-time** basis per new client. Clients who have already participated in the promotion are ineligible for future claims.

2. Minimum Deposit Requirement

- In order to qualify for the **30% Deposit Bonus**, clients must deposit a minimum of **\$50** into their live trading account.
- Deposits below this amount will not be eligible for the bonus. The bonus will be calculated based on the **first deposit** made after account activation.

3. Bonus Percentage

- The Bonus is calculated as **30%** of the client’s first deposit.
- Example:
 - For a **\$1,000** deposit, the client will receive a **\$300** bonus.
 - For a **\$500** deposit, the client will receive a **\$150** bonus.
 - For a **\$5,000** deposit, the client will receive a **\$1,500** bonus.
- The Bonus will be credited to the client’s trading account automatically upon receipt of the deposit, subject to the successful confirmation of these Terms & Conditions.



4. Maximum Bonus Amount

- The **maximum bonus** a client can receive is **\$1,500**.
- This is the maximum amount achievable through a deposit of **\$5,000**. Any deposit higher than this will still result in a bonus of **30%**, but the bonus amount will not exceed **\$1,500**.

5. Bonus Crediting

- Upon successful deposit and the client's acknowledgment of these Terms & Conditions, the Bonus will be **credited directly to the client's trading account**.
- The Bonus is **not available for immediate withdrawal**. It is solely intended for use in trading and is subject to the volume-based conditions outlined in Section 6.

6. Trading Volume Requirements

- In order to be eligible to withdraw the Bonus, clients must meet the required **trading volume** based on the Bonus amount they received. The required volume is calculated using a **1:10 lot factor**, meaning that clients must trade **1 standard lot per \$10** of Bonus received.

Example Calculations:

- **For a \$50 deposit**, the client will receive a **\$15 bonus**. The client must trade **1.5 lots** before the Bonus becomes eligible for withdrawal.
- **For a \$500 deposit**, the client will receive a **\$150 bonus**. The client must trade **15 lots** before the Bonus becomes eligible for withdrawal.
- **For a \$5,000 deposit**, the client will receive a **\$1,500 bonus**. The client must trade **150 lots** before the Bonus becomes eligible for withdrawal.
- **Eligible Trades:** Only **real, executed trades** will count towards the required trading volume. Any trades considered as **hedging, arbitrage, or other suspicious activity** will not be counted and may result in the cancellation of the Bonus and any associated profits.
- The volume calculation will be based on the total number of **standard lots traded**. Other types of contracts or instruments (e.g., micro lots) will be converted into equivalent standard lots at the Broker's discretion.

7. Withdrawal Conditions

- **Bonus Release:** The Bonus is **locked** and will **only become available for withdrawal** once the required trading volume has been met as per the conditions set forth in Section 6.

- If the client attempts to withdraw funds prior to meeting the volume conditions, the **Bonus will be forfeited**. Additionally, the client may be required to cover any associated withdrawal fees determined by Icon FX.
- Once the required volume has been traded, the Bonus will be **released**, and clients can proceed to withdraw their Bonus funds along with any profits generated from trading.

8. Bonus Expiry

- The Bonus is valid for **30 calendar days** from the date of the first deposit.
- If the required trading volume has not been met within **30 days**, the **Bonus will be forfeited** and removed from the account.
- It is the client's responsibility to ensure they meet the required volume within the given timeframe. No extensions will be provided.

9. Bonus Restrictions

- **Non-Withdrawable:** The Bonus is intended solely for use in trading and cannot be directly withdrawn until the required volume is met.
- The Bonus is **not transferable** between accounts.
- The Bonus cannot be combined with any other ongoing promotions, bonuses, or offers provided by Icon FX. Only one Bonus per client is permitted.
- Clients who abuse, manipulate, or engage in fraudulent activity related to this Bonus promotion will be immediately disqualified, and their accounts may be suspended or terminated.

10. General Terms

- Icon FX reserves the right to **modify, amend, or cancel** the 30% Deposit Bonus promotion at any time, with or without prior notice. Any changes will be communicated to clients, and the updated Terms will apply from the moment they are posted on the official Icon FX website.
- Icon FX reserves the right to **refuse, cancel, or revoke** the Bonus or any winnings derived from it if any fraudulent, suspicious, or abusive behavior is detected.
- In the event of a dispute or ambiguity related to the Terms, the decision of Icon FX will be **final** and binding.
- All clients participating in this promotion must comply with Icon FX's **General Terms and Conditions** and **Risk Disclosure Statement**, as updated from time to time.
